New chair at East Gippsland Water

Minister for Water Peter Walsh today announced the appointment of a new chair to the East Gippsland Water board.

"I am delighted to welcome Joe Rettino as the new chairman of the Gippsland Water board," Mr Walsh said.

"Mr Rettino has strong management skills and knows his community extremely well, having served as a mayor and councillor for the City of Bairnsdale and also on several school boards.

"I also congratulate Michelle Dowsett and Geoff Ellis on their reappointment as directors, following strong service to East Gippsland Water in their current terms."

Mr Walsh also announced that Terry Swingler, former Yarra Valley Water general manager for finance, has been appointed director at the board of Southern Rural Water.

Horticulturist Terry Burgi, dairy and beef farmer Russell Napper, and dairy farmer Naomi Pye, have all been reappointed for another term on the Southern Rural Water board.

Mr Walsh thanked outgoing East Gippsland Water chair Gail Morely and outgoing Southern Rural Water director Harry Peeters for their service to the community and to Victoria's water industry.

The appointments were among 22 new appointments and 57 reappointments announced by Mr Walsh today for Victoria's 19 water corporation boards.

"The Victorian Government is committed to appointing water corporation boards that balance skills in sound governance, financial management, water industry experience and community connection." Mr Walsh said.

"I am confident we are bringing together highly skilled individuals who can deliver high quality, efficient and sustainable water services to local communities."

An expression of interest process is undertaken each year as board directors' terms expire. This year more than 420 expressions of interest were received.

The new appointments commence on 1 October 2013.
