



## EAST GIPPSLAND WATER

### Tariffs, Charges & Pricing Principles 1 July 2020 – 30 June 2021

At the Board Meeting held on the 16<sup>th</sup> of June 2020 the Board of East Gippsland Water resolved to adopt the following tariffs, charges and pricing principles, issued by the Essential Services Commission.

The annual tariffs for all districts covered by East Gippsland Water are set out below. Accounts will be issued and will be payable at least 28 days after the date of issue of the notice, at locations identified on the account.

Accounts are issued on an approximate three-monthly billing cycle for all districts.
