## Permanent Water Saving Rules

The Victorian Government's Permanent Water Saving Rules are recommended to be used at all times when no other water restrictions are in place. Key rules include:



## RESIDENTIAL AND COMMERCIAL GARDENS AND LAWNS


Can be watered using a watering system, between 6pm and 10am. Can be watered with a hand-held hose fitted with a trigger nozzle, bucket or watering can at any time.



#### **VEHICLE WASHING**

- including car, boat, motorbike and other vehicles

Can be cleaned at any time, but only if using a hand-held hose with a trigger nozzle, a high pressure water cleaning device, a watering can or a bucket.



#### **HARD SURFACES**

 including driveways, paths, timber and concrete decking or building facades

Can only be cleaned if it is required as a result of an accident, fire, health or safety hazard or other emergency, using a high pressure cleaning unit, hose fitted with a trigger nozzle or bucket.



#### **FOUNTAINS AND WATER FEATURES**

Can only be used if they recirculate the water.

Permanent Water Saving Rules and Water Restrictions do not apply to tank, bore or grey water.

# **Summary of Water Restrictions**

(Including Permanent Water Saving Rules)



During periods of dry weather conditions, there may be a requirement to implement Water Restrictions across the East Gippsland region.

Water restrictions have an immediate benefit in helping to preserve water supplies. Constraints are introduced on how customers can use water and they generally only apply to outdoor water use.

During any stage of water restriction, water can be used at any time for human health requirements, stock and animal health requirements, firefighting and the safety (not cleaning) of vehicles and equipment.

## **Water Restrictions**

These are introduced when it is clear that the supply of water is depleting at a rate that cannot keep pace with customer demand, this could be due to low stream flows and ongoing drought conditions. Restrictions range from 1 (Alert to 2 (Critical). The impacts of water restrictions:
